The Parish Council is inviting companies to quote for its annual hedge cutting programme.

We are seeking a price for these works for 2021-22 with the option to extend for an additional 4 years.

If you wish to quote for this work, please note the following

- Hedges to be hand cut are shown in the maps indicated by a red line mark up on pages 4-9. (Summary of the entire area on page 10)
- Unless otherwise stated all hedges are to be cut to a height of 1.8 metres and the entire width of the hedge to be cut. (Please only access via Parish Council or public land)
- If the other side of the hedge is accessible by a road or public space, please cut both sides.
- Please sever the Ivy from the Trees in the hedges.
- All foliage / scrub under hedges to be strimmed down and removed.
- All waste to be removed from site and pavements swept clean.
- The width of the hedge should be cut back to give maximum clearance to footpaths, pavements and public space.
- Work may be completed in stages between October and February 2022 to suit the successful contractor. The Clerk to be informed of dates when work will take place with a minimum of 3 days' notice so that the office can advise the priority order and communicate to residents.
- All significant trees (note may include newly planted indicated with stakes) to remain in hedgerows, with crowns lifted, if necessary. This is so trees do not impinge vehicle or pedestrian access.
- All estimates must be received by 23rd September 2021 to be considered and be submitted on the form on page 2 of this tender. Please return in a sealed envelope using the label on page 3.

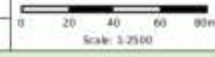

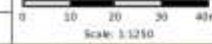

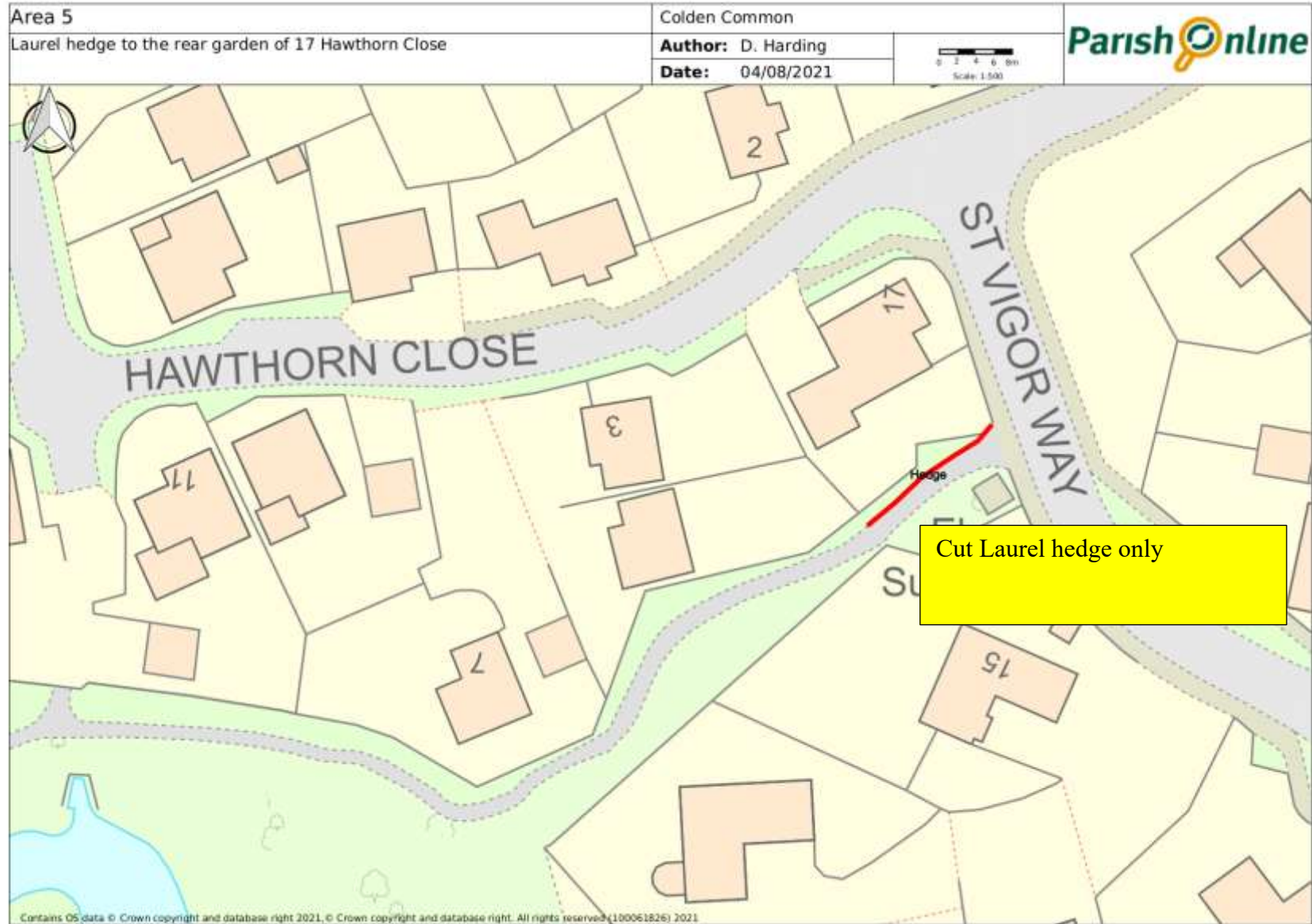
